About the Conference

It also provides the premier and multi-disciplinary forum for researchers, practitioners and educators to present and discuss the most recent developments, trends and concerns practical challenges encountered and the solution adopted in the field of mathematics, statistics, operations research, Agriculture Statistics, Biostatistics, combinatorics, bio informatics, computations techniques, computer science.

The conference would be studded with a Keynote Address, M.N. Das Memorial Lecture, Special Invited Lectures, Invited talks by Young Researchers and Contributed papers session. Call for Papers

The organizers invite original and unpublished research papers from academia, industry experts and students/research scholars to present their work orally and through poster in the broad areas of the major themes outlined. The abstract of the contributed paper should focus on the items such as objective of the study, methodology, research findings, significance and scope of the study. There will be a review on the abstracts by experts and selection of the paper is based on the recommendations of the expert committee. The authors of selected abstracts would be asked to present their study during the conference. The invited speakers are also expected to submit their abstract in similar fashion.

The abstract should not exceed 300 words type data word file, Fontsize 12, Font type Times New Roman, should include Title of the Paper, Author(s) name(s) and their affiliations with email and Keywords. Pilgrimage of Mata Vaishno Devi is said to be one of the holiest pilgrims in the world. Shri Mata Vaishno Devi resides in a cave which is situated in the three peaked mountain called Trikoot. Lakhs of devotees pay homage to Mata Vaishno Devi ji every year. The holy cave of Mata Vaishno Devi ji is located at the height of 5200 ft. Devotees mostly stay at Katra which is about45 km from Jammu and trek up a path of 12Km. Darshans for Mata Vaishnodevi Ji is open 24 hours a day throughout the year. Helicopter service and for other bookings one can browse www.maavaishnodevi.org.

Famous Cave shrine of "Shivkhori" is about 110 km from Jammu, depicts the natural formation of Shivlingam. It is one of the most venerated cave shrines of Lord Shiva in the region. The Holy Cave is more than 150 mts long & houses 4 feet high Svayambhu Lingam, which constantly bathes in a milky lime fluid dripping from the ceiling. The cave is full of natural impressions and images of various Hindu Deities.

How to Reach Jammu

Jammu is the winter capital of the UT of Jammu and Kashmir and is well connected by roads, rail and air with different parts of the country.

By Air: Jammu has direct flights to and fro from Delhi/Mumbai, and well connected to other major cities of the country. Jammu Airport is located at a distance of approximately 5 Kilometres from Jammu University campus.

By Rail: There are daily trains connecting Jammu to New Delhi, Mumbai, Lucknow, Varanasi, Gorakhpur, Jaipur, Indore, Kolkata, Chennai etc. Jammu Tawi railway station is located at a distance of approximately 2 KM from Jammu University campus.

By Road: Jammu is well connected by good road network connecting it to various cities and towns across India. Various government as well as private agencies offers daily bus services to various destinations in the UT of J & K and the neighbouring states. General Bus Stand, Jammu is located at a distance of approximately 2 KM from Jammu University campus.

Climate and Clothing: Climate in Jammu during the month of February would be moderate with day time temperature varying between 20-25 degree centigrade while night time temperature varying between 10-15 degree centigrade. Light woollens during the day time are recommended.
